#### **"Polysafe Stud Tile" (or "Polystud"):**

Decorative pressed , raised stud, single layer homogeneous synthetic rubber floor tile.

Thickness : 3 mm - Weight per unit area: 4.8 kg/m<sup>2</sup>

Tested glued on calcium silicate board (12 mm, 870 kg/m<sup>3</sup>) with acrylic base glue ("Styccobond F44" from F Ball & Co, application rate 200 g/m<sup>2</sup>)
